4. Voordat 'n applikant as 'n Junior Beoordelaar aangestel kan word, moet hy as 'n Skoubeampte by vyf (5) Provinsiale of Streeksskoue, en twee (2) Nasionale Skoue diens gedoen het. Diens kan gedoen word in 'n minimum van twee (2) jaar. Nadat 'n persoon gekwalifiseer het as 'n Junior Beoordelaar moet die applikant vir ten minste drie (3) jaar een (1) skou per jaar as Beoordelaar of Skoubeampte by 'n Nasionale Skou diens doen voordat die finale skriftelike toets afgelê kan word. Voorkeur sal verleen word aan lede wat hul eksamens as Skoubeamptes by SANPO afgelê het.

Before becoming a Junior Judge, the applicant must be a Steward at least on five (5) Provincial or Union shows and two (2) SANPO shows. This can all be done in a minimum of two (2) years. After qualifying as a Junior Judge, an applicant is required to judge for a minimum of three (3) years at one show per year or as a Steward at the yearly SANPO show before writing the test. Preference will be given to persons doing their show exam as Steward at the SANPO shows.
